

# Farmland (Zone 2) Antlerless Harvest Authorization Pickup


If a customer did not get the Farmland Zone Antlerless Harvest Authorization(s) when they purchased their license, they can still get them for free online or at a DNR service center. They are also available at non-DNR agents for a \$2 charge.

- **Customer Catalog.** Select the **Hunt/Trap** tab. Select the Farmland (Zone 2) Antlerless Deer Harvest Authorization from the Product list on the Customer Catalog.

- **Harvest Authorization Choices.** Select the county (deer management unit/zone) and land type for each Harvest Authorization. *NOTE: You will see a selection for each license purchased (gun and archer). Conservation Patron holders or customers who have purchase multiple license types will see two selections.*
  - Select the **Map Link** to display a state map of all the deer management units and their boundaries.
  - Select the **Management Zone/Unit (county)** the customer plans to hunt. The drop-down list will show only the counties that have Farmland Zone Antlerless Harvest Authorizations available. Once the county is selected, you will see the number of antlerless Harvest Authorizations the customer will receive. Designate the land type for each harvest authorization requested (**public or private**). *EXAMPLE below: Milwaukee County offers 2 antlerless Harvest Authorizations. Both must be used in Milwaukee, but they may select public or private for each.*



**Farmland (Zone 2) Antlerless Deer Harvest Authorizations**

Antlerless tags are offered with each deer license for the Farmland (Zone 2) areas of the state.

You can obtain your antlerless tags at any time before the end of the deer season online or at a DNR Office for no additional fee, or at a Non-DNR agent with a \$2.00 processing fee. When taking the farmland tag(s), you are able to select one unit for each deer license, but you must accept the full quantity of tags for each unit. See the below map for details on tag availability and quantity.

- Shopping Cart.** Confirm the County, Zone and Land Type with the customer. If the information is wrong, you can touch the Remove button on the gun deer license and select Keep Shopping to try again. If correct, select Checkout, confirm payment, and have the customer sign. **NOTE:** For non-DNR agents, the cost will be \$2 if it is the only product in the transaction. If the customer purchases other products in the same transaction, the \$2 fee will be eliminated

**Farmland (Zone 2) Antlerless Harvest Authorization(s):** This comes with all deer licenses. It is valid for one antlerless deer in the county specified. The customer may receive anywhere from 0-5 of them, depending on the county they have chosen to hunt. The Harvest Authorization is not weapon specific, and can therefore be used with a gun, archer or crossbow license. Harvest Authorizations no longer need to be validated or attached to the deer. Registration requirements have not changed. Hunters will need the unique harvest authorization number to complete the registration process.
