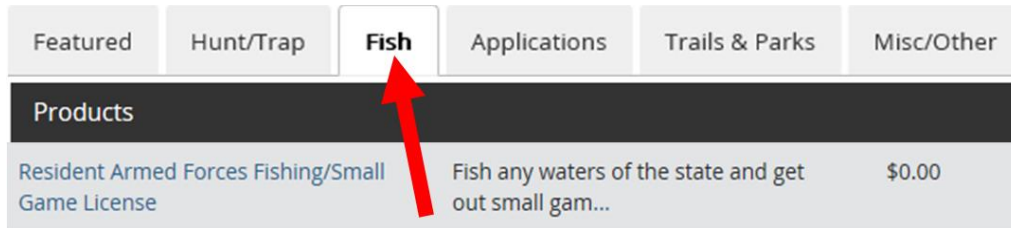


Active-Duty Fishing/Small Game

The Active-Duty Fishing/Small Game License is a reduced rate license for those individuals on Active Duty with the Armed Forces and are on furlough or leave. The customer must show proof of this at time of purchase.

- **Customer Catalog.** Select the “Fish” tab on the Customer Catalog. Select the [Resident Armed Forces Fishing/Small Game License](#) from the license catalog. The cost is \$0.00 for qualified customers.



- **Add-ons.** There is an optional add-on for [HIP certification](#). All other stamps associated with the fishing/small game license are included (Salmon and Trout, pheasant, and state waterfowl). Select Add to Cart.

- **License qualifications.** The customer must provide additional documentation to qualify for this reduced rate license. Select the [boxes below](#) if they meet all three of the qualifications listed. **Note: If the customer does not qualify for all three of the eligibility requirements, they do not qualify for this license. NOTE: Proof of furlough or leave must identify the individual by name and show the dates they are on leave.**

- **HIP Certification.** If HIP certification was selected, you will then be prompted to enter their Harvest Information Program information. This is a survey of the waterfowl harvest they had from last year. Ask the customer all the questions on the screen and hit Continue.
