TWO WAYS TO SELL:



<u>Recommended</u>: Search for the Customer's DNR account and sell from Trails & Parks tab. This way you can use "address on file" and won't have to re-type the shipping address.



If you go through Quick Sale from the Main page, you will need to enter the mailing address, and the customer number will record as zero.

Snowmobile Trail Pass Information

Snowmobiles operating on a Wisconsin trail or corridor (except antique sleds with a model year of 35 years or more) must display a valid snowmobile trail pass. Trail Passes are separate from snowmobile registration.

The snowmobile trail pass fee is dependent upon whether the snowmobile is registered in Wisconsin or another state. Trail pass fees are non-refundable. Customers will need their Wisconsin registration number for a Wisconsin Trail Pass, or the make and model for a nonresident snowmobile trail pass. All passes will be shipped by US Mail within 2 business days. A temporary trail use receipt is issued to operate legally on snowmobile trails. *PLEASE NOTE: TRAIL PASSES ARE NONREFUNDABLE AND CAN ONLY BE VOIDED ON THE SAME DAY AS SOLD.*

- Wisconsin snowmobile trail pass for a snowmobile registered in Wisconsin.
- Nonresident snowmobile trail pass for a snowmobile registered outside of Wisconsin
- Wisconsin snowmobile trail pass for club members FOR A SNOWMOBILE REGISTERED IN WISCONSIN AND
 OWNED BY A PERSON IS BOTH A MEMBER OF A SNOWMOBILE CLUB AND A MEMBER OF AWSC CUSTOMERS

ATV Trail Pass Information

ATV Trail passes are only required for nonresidents who wish to operate their ATV or UTV on Wisconsin trails. Nonresidents must acquire <u>either</u> a valid Wisconsin registration <u>or</u> a Nonresident Trail Pass.

- **Nonresident Annual ATV or UTV Trail Pass** The pass expires on March 31 of each year. A temporary operating receipt allows the customer to operate immediately while the physical trail pass decal is in the mail
- Nonresident 5-Day ATV or UTV Trail Pass The customer must indicate the start of the 5-day period at time of purchase. The customer is able to immediately begin riding on day one of their 5-day period, and will need to carry this document while on the trails. No decal or sticker is mailed.

OHM Trail Pass Information

OHM Trail passes are only required for nonresidents who wish to operate their OHM on Wisconsin trails. Nonresidents must acquire <u>either</u> a valid Wisconsin registration <u>or</u> a Nonresident OHM Trail Pass.

- **Nonresident Annual OHM Trail Pass** An annual trail pass for nonresidents. The pass expires on March 31 of each year. A temporary operating receipt allows the customer to operate immediately. The trail pass decal will arrive in the mail in approximately two weeks.
- Nonresident 5-Day OHM Trail Pass A temporary (5 Day) trail pass for nonresidents. The customer must indicate the start of the 5 day period at time of purchase. The customer is able to immediately begin riding on day one of their 5 day period, and will need to carry this document while on the trails. There is no decal or sticker that is mailed when purchasing the 5-Day Pass.
