


Fall Turkey Application

There is an application process for hunting fall turkey. A customer must first pay the application fee and submit their hunting zone choices. The deadline for submitting this application is August 1. They will then be entered into a drawing which will determine if they receive a harvest tag. They will receive notice in the mail if they were successful in the drawing and may then purchase their turkey license.


- Select the [Applications](#) button on the Customer Dashboard. You can also find it under the Hunt/Trap button as well.



- Select the Fall Turkey Application from the Products list.

- The next screen will show the Fall turkey application description and price. Select Add to Cart



- The next screen is where you will do the bulk of the application:
 - It will first ask you if the customer wishes to claim landowner preference. Have the customer read the qualifications below and check either **yes** or **no**.
 - Enter the turkey hunting zone(s) that the customer wants to apply for. (For a map of the turkey zones, touch the **map link**). They can make **up to two zone choices**, and should indicate their choices in order of preference, with the most desired zone first.
 - Ask the customer if they wish to hunt for turkeys as a group. If yes, enter the **group leader number** they have decided on in the box

Landowner Preference

Landowners may be Wisconsin residents or non-residents. To qualify, you must personally own 50 or more acres in one tract within the management zone you select as your first choice to be eligible for landowner preference in that zone. The acres may be adjacent to one another to make up the 50 acre tract. You are not required to live on this tract. (Note: This does not mean that a different person may apply with landowner preference for each 50 acres within one ownership.)

Providing incorrect information and claiming landowner preference without meeting the legal qualifications is a violation of state law and is punishable by a penalty in excess of \$500 and a revocation of all hunting, fishing and trapping privileges for 3 years.

Transfer of Landowner Preference: Under the preference system you can apply for, or if a Wisconsin resident, may transfer your landowner preference. If the land is under joint ownership, only one of the owners may apply for or transfer landowner preference. Non-resident landowners cannot transfer preference

Group Application

A maximum of 4 people, who wish to hunt together, may apply as a group. Each member of the group must submit an application. If group members have different preference status, the lowest preference will be used for the group. Group members must request identical zones and time periods in the same order. If different, the choices on the group leader's application will be used.

Select one member of the group as the 'Group Leader'. Enter the Group Leader's DNR Customer ID Number on each group member's application. The Group Leader must enter his/her own DNR Customer Number as well. Failure to enter a Group Leader's DNR Customer Number will disallow you from the group.

Printing – The system will print a paper receipt showing the customer did submit their application. There is no license document since this is just an application. Ask the customer to review the choices printed on the receipt to make sure they are correct. It is a good idea that they hang on to this receipt as proof of application.

Recreational License Purchasers:
 I hereby certify that I am a Wisconsin resident and have maintained my permanent residence in Wisconsin for the previous 30 days and that I am eligible for these approvals. I understand that providing incorrect information and/or claiming landowner preference without meeting the legal requirements is a violation of state law and punishable by penalty and revocation of all hunting, fishing and trapping privileges for 3 years. A hunting license issued by the Department of Natural Resources does not authorize the possession of a firearm by a felon or anyone who cannot possess a firearm due to a conviction for a crime of domestic violence. I have complied with all the laws regulating the issuance and purchase of this license, and certify that my privileges are not otherwise revoked or suspended.

You ARE NOT eligible to use your Wisconsin Driver's License for display of recreational approvals. Please visit dnr.wi.gov for more information on how to get your DL verified for use.

Questions...

Why doesn't the application show up on the screen for purchase?

Answer #1: The customer may have already purchased this application earlier in the year. They can call the DNR Call Center at 1-888-936-7463 to find out

Answer #2: The deadline for that particular application may have already passed

What do I do if the customer does not know their zone or time period choices at this time?

Answer: Cancel the transaction and inform the customer that the choices must be entered at the time of sale. They can return and purchase the application at a later time, or they can also apply online at www.dnr.wi.gov

If a customer already applied this year, can they change their zone or time period?

Answer: They can change their zone and/or time period if the deadline for submitting the application has not yet passed, however they cannot do so at your location. They must make the changes on the DNR website, or they can contact the DNR Call Center at 1-888-936-7463 to get more information on how to do so.
