


# Upriver Sturgeon Spearing: Preference Point Application

There is an application process for Upriver Sturgeon. The deadline for submitting this application is August 1. This tutorial is for the application if a customer just wants their preference point and does not wish to be in the drawing.


- Select the [Applications](#) button on the Customer Dashboard.



- Select the **Upriver Sturgeon Spearing PREFERENCE POINT Application** from the Products list. This product will not show on your screen after August 1. By choosing this product, the customer will receive their preference point for Upriver Sturgeon Spearing, but WILL NOT be placed into the drawing to receive a tag.

- The next screen will show the application description and price. By choosing this application for preference point only, the customer will be allowed to also purchase their Lake Winnebago Sturgeon Spearing License as an add-on at this time if they wish. Select Add to Cart.



- The next screen will be the shopping cart, since no zones or seasons need to be chosen because it is for preference point only. Review with the customer and confirm they are correct. You will also see the Winnebago Sturgeon Spearing License (\$20) if the customer chose it as an add-on. Then select Checkout to proceed. Confirm Payment and have the customer sign.

**Printing** – The system will print a paper receipt showing the customer submitted their application. Ask the customer to review the receipt to make sure they are correct. It is a good idea that they hang on to this receipt as proof of application. They will receive their harvest tag in the mail if they were successful in the drawing. **NOTE: There is no license document for the application, but a license will print for the Winnebago Sturgeon License if the customer chose it.**

I hereby certify that I am a Wisconsin resident and have maintained my permanent residence in Wisconsin for the previous 30 days and that I am eligible for these approvals. I understand that providing incorrect information and/or claiming landowner preference without meeting the legal requirements is a violation of state law and punishable by penalty and revocation of all hunting, fishing and trapping privileges for 3 years. A hunting license issued by the Department of Natural Resources does not authorize the possession of a firearm by a felon or anyone who cannot possess a firearm due to a conviction for a crime of domestic violence. I have complied with all the laws regulating the issuance and purchase of this license, and certify that my privileges are not otherwise revoked or suspended.

You ARE NOT eligible to use your Wisconsin Driver's License for display of recreational approvals. Please visit [dnr.wi.gov](http://dnr.wi.gov) for more information on how to get your DL verified for use.

Valid on Lake Winnebago from second Saturday in February for 16 consecutive days or until one or more harvest caps are reached. Immediately upon harvest, write the date and AM/PM. The person who harvested the fish and this tag must accompany the sturgeon until it is registered at a DNR registration station.
